Dear Parents,

As part of our history topic about the Romans during Year 4, children will be given an opportunity to attend a very exciting residential visit to Ufton Court. The trip will run from 29th June to 1st July, consisting of three days and two nights and will involve a variety of indoor and outdoor activities to help bring the topic of the Ancient Romans to life. Children will be immersed in the culture of Ancient Rome through practical learning experiences, including a Roman Feast (costumes will be provided), trebuchet making and historical re-enactments as well as many more! We have visited Ufton Court many times and the expertise of the staff and practical opportunities to enrich your child's education are excellent.

As a school, we are mindful of rising costs and we have worked with Ufton Court to ensure this trip represents good value for money. The exact cost will be calculated when we are able to confirm how many children will be going (we are hoping every child will participate!) but this will be a maximum of £172. This will include the residential visit (accommodation, food, activities and costumes) and travel by coach to and from the venue.

To secure a place, please return the permission slip and make a non-returnable deposit of £25, via Tucasi, by Friday 14th February 2020. The balance should be received by Friday 19th June 2020 and may be made as a single payment or in regular instalments. The balance will then also be non-returnable as we have to settle our accounts at this time.

You are invited to a short information meeting about the visit on Wednesday 5th February 6.00-6.30pm, which will give you an opportunity to receive more details and ask any questions that you may have. Please indicate your attendance at this on the reply slip below. In school, all of the Year 4 children have been told about the fantastic learning opportunity this will be as well as shown photographs of Ufton Court from previous trips. Therefore, the information meeting will be for parents only.
